## Application

- 1. Add to gauging water at the appropriate dosage.
- 2. Ensure sand for mortar complies with the appropriate British Standard and that the work is carried out in accordance with BS 5628 Part 3.
- 3. All materials must be free from ice and the temperature of the mix prior to placing should not be below +4°C.
- 4. Keep the mortar above freezing point until minimum strength is attained by covering with a plastic sheet.

Ambient temperature expected	850 - 900ml	
to fall to -4°C	per 25kg cement	
Ambient temperature expected	1700 - 1800ml	
to fall below – 4°C	per 25kg cement	

#### Cleaning

1. Clean tools and equipment immediately after use with water.

Sealocrete Sealofrost CFA is not recommended for use with high alumina, extra rapid, super sulphate cements. Do not use in lime-based mixes. Do not overdose. Do not use with other admixtures.
